Lloyds Bank has notified the Town Council of two lots of maturing funds on the 9th April 2021 (£651,479.00 and £179,185.49) and Cllr S Hitchings has obtained the rates below:

Santander

6 Months' notice – 0.30%

1 Year notice – 0.40%

Lloyds

6 Months' notice – 0.02%

1 Year notice – 0.05%

Hampshire Trust (HT)

1 Year notice – 0.75%

2 Year notice – 0.80%

We would need permission from the HT management to go over a 1 Million pounds of investment with them as we already have £932,603 invested.

Cambridge & Counties Bank – Suggested by Mark Davis from the CCLA

2 Year Bond – 0.90% Gross/AER (minimum investment £25K)

5 Year Bond – 1.15% Gross/AER (minimum investment £10K)

Recommendation

Cllr S Hitchings has determined that we should move away from the High Street banks with our investments due to the low interest rates and recommends the following investments for councillors to consider:

Lloyds Time Deposit S106 (Matures 9th April 2021) - £651,479.00 + Interest

Move to Cambridge and Counties Bank – 2 Year Fixed Rate Business, Trust and Charity Bond 0.90% Gross/AER Fixed.

Lloyds Time Deposit S106 (Matures 9th April 2021) - £179,185.49 + Interest

Move to Santander 95 day notice account which has a rate of 0.45% compared to Lloyds 12 month account at 0.05%.

The latter does not require council approval as we already bank with both businesses, but it is recommended that one resolution is made.
